

# Issuing pleasure boat registration or licensing

## **About the Service**

This service allows the customer to register or license a national or foreign pleasure boat

#### **Service Process**

- Login using UAE PASS account.
- Fill in the required field and attach the required documents.
- Submit the service.
- Pay the fees.
- · Obtain the service

## **Expected Time**

One working day

#### **Service Fees**

• AED 100 - 10000 AED (check fees details)

#### **Fees Details**

- UAE national: Registration fee for a pleasure boat owned by a UAE national tonnage x AED 4.5, with a minimum of 100 AED and a maximum of 10,000 dirhams annual tax. Total tonnage x AED 2 with a minimum of 20 AED
- Foreigner: Foreigner-owned excursion boat registration fee payload x 6.5 minimum AED 500

## **Terms and Conditions**

- The age of the applicant for registration shall not be less than (18) eighteen years old
- The total monthly income is not less than 20 thousand dirhams according to a salary certificate issued by a competent governmental authority or official Labour Contract for employed with non-Government organization ,owner /partner in a commercial license, and its capital should not be less than 150 thousand dirhams (Applicable for Foreigners owners)

# **Service Connectivity (External)**

After the customer registers for the service, he is required to print a no-objection letter from the system and take it to the Critical Infrastructure & Coastal Protection Authority to complete the necessary

## **Required Documents**

The required documents issued by approved authorities require a stamp, taking into consideration that the digital stamp is acceptable.

- Copy of the emirates ID (both sides)
- {Original Invoice duly attested by the Chamber of the Commerce or building certificate for new boat} {Original Bill
  of Sale and Deletion certificate issued by MOEI, Court or one of the competent official authorities for used boat }
  {Duly attested customs manifest for imports boats from UAE Embassy from the country of origin and Ministry of
  Foreign affairs in UAE}
- Ownership card of a boat trailer registered by the traffic Department OR Parking certificate for the boat at one of the UAE marinas OR a scheme (outline) of ownership of a house on the sea, or if residents of one of the islands
- A boat insurance policy valid for 13 months
- Inspection report from CICPA (Coast Guard)
- Salary certificate or Official Labour Contract for employed with non-Government organization with minimum salary of AED. 20000 Or Owner partner in a commercial license and its capital is not less than 150 thousand dirhams or any proof of income which MOEI will approve. (Applicable for Foreigners)
