



## Renewal of a national transportation vehicle permit

### About the Service

This service allows establishments to renew a land transportation permit to operate in the field of activity licensed in the country (goods or passengers) when the expiration date is close or 30 days before the expiration of the license, or when it expires with a grace period of 30 days after expiration. (Request to renew an operating card for national vehicles)

### Service Process

- Login using UAE PASS account
- Fill in the required field and attach the required documents
- Apply for the service
- Pay the fees
- Obtain the service

### Expected Time

- One working day

### Service Fees

- 100AED - In addition to 5 AED per seat for passenger vehicles, 10 AED per ton for the total load of goods transport vehicles. delay fee if it is not renewed or cancelled within 30 days from the date of expiry (50 dirhams for each month of delay or part thereof, with a maximum of 150 dirhams for each activity)

### Terms and Conditions

- The applicant must attach a copy of (1) ownership of the means of transport or the registration papers of the means of transport.
- The activity licensee/agent/branch owner must submit a copy of the operating license for the activity issued by the Ministry.
- The means of land transport must be equipped with safety measures and meet all technical conditions required by the competent authority.
- The applicant must attach a valid insurance document that covers the United Arab Emirates, the insurance must cover the following: The means of transportation to be licensed. Driver, assistant and passengers Civil compensation.

## FAQ's

- What are the required documents to renew the national transportation vehicle permit (operational cards)? A copy of a valid vehicle ownership (including insurance) or transportation registration papers
- What are the fees to renew the national transportation vehicle permit (operational cards)? 100 AED - In addition to 5 AED per seat for passenger vehicles, 10 AED per ton for the total load of goods transport vehicles. delay fee if it is not renewed or cancelled within 30 days from the date of expiry (50 dirhams for each month of delay or part thereof, with a maximum of 150 dirhams for each activity)
- Is the customer required to visit printing offices to complete the procedures for applying for land transportation services? The customer is not required to visit printing offices. Services are provided through the official channels of the Ministry

## Required Documents

**The required documents issued by approved authorities require a stamp, taking into consideration that the digital stamp is acceptable.**

- A copy of a valid vehicle ownership (including insurance) or transportation registration papers
- Service Code: MOEI-10049
- Service Type: G2B
