- 1. The applicant must be a citizen holding a family book and an identity
- 2. To be the breadwinner for a female family in which the children and the wife are citizens. If the wife is not a citizen, he must have children from her, or that a period of no less than (7) years has passed from the date of marriage.
- 3. He should not be the owner of a suitable dwelling for habitation
- 4. That the applicant has not previously obtained housing assistance from a government agency in the country.
- 5. The applicant should not have previously disposed of a suitable dwelling owned by him in a transferable manner unless a period of not less than (10) ten years has elapsed from the date of disposal.
- 6- The applicant should not be financially able so that his total income or property does not allow him to own a suitable house, make the necessary addition or complete the construction of his house, and the applicant is considered capable in the following cases:
- (a) If he is the owner of one or more properties, he can dispose of some of them in a manner that meets his housing needs, provided that this is proven by a report issued by an official authority.
- (b) If he is the owner or partner in any or more commercial activities that achieve financial returns exceeding (100,000) one hundred thousand dirhams per month.
- (c) If his monthly income from salary and other financial returns exceeds the amount of (100,000) one hundred thousand dirhams per month.

What are the general requirements for providing housing assistance?

To obtain housing assistance, the following are required:

- 1. The applicant must be a citizen holding a family book and identity card.
- 2. The applicant must be a breadwinner for a local family where the kids and the wife are locals. If the wife is not a UAE citizen, it is required that the applicant has children from her, or they are married for more than 7 years.
- 3. The applicant should not have previously disposed of a suitable dwelling owned by him in a transferable manner unless a period of not less than (10) ten years has elapsed from the date of disposal.
- 4. The applicant should not be financially able and his monthly income from salary / real estate does not exceed (100,000) dirhams per month.

What are the requirements for providing housing assistance to this category?

- Special needs:
 - a. To obtain an authorized special needs card
 - b. Male gender
 - c. 21 years old
- Senior citizens:

The following conditions are required to obtain housing assistance:

- a. To be (60) sixty years or more, whether male or female.
- The orphan:

The following conditions are required to obtain housing assistance:

- a. Father is deceased.
- b. Age is less than (21) twentyone years old, whether male or female.
- c. Mother is not entitled to housing assistance.

One housing assistance is granted

to the orphan siblings.

- The custodial widow:
 - a. The following conditions are required to obtain housing assistance:
 - b. Husband is deceased.
 - c. A custodian for male children under the age of (24) twentyfour years, unmarried and not working, or unmarried females.
- The custodial divorcee:

The following conditions are required to obtain housing assistance:

- a. Age should not be less than(30) thirty years, period of divorce should be more than(5)) five years.
- b. A custodian for children whose father is unable to provide a suitable children's house.

- Unknown dynasty:
 The following conditions are required to obtain housing assistance:
 - a. To prove that she is of unknown dynasty (of unknown mother and father) by a court ruling or by a certificate issued by a competent court in the country.
 - b. Age is not less than (30) thirty years old.
- c. Social research's proof conducted by the Ministry or the competent authority in the country, her need to obtain housing assistance, taking into consideration her circumstances.
- Both Parents Orphan
 The following conditions are required to obtain housing assistance:

- d. Female and both of her parents (father and mother) have passed away.
- e. Unmarried, divorced or widowed, doesn't have children, or children beyond the age of custody.
- f. Not less than (30) thirty years of old
- g. Social research proof conducted by the Ministry or a competent authority to prove that it is impossible for her to continue living with her family, or that she is residing in an independent house that she does not own permanently. In the case of all sisters eligible, they are granted one housing assistance.

 A woman married to a noncitizen

The following conditions are required to obtain housing assistance:

- a. Age is not less than (40) forty years old.
- b. To have male sons whose age does not exceed (24) twenty-four years old, who is unmarried and unemployed, or unmarried daughters.
- c. Women and her children are residents in UAE, and registered on her or their father's residency.
- d. Husband is unable to provide suitable housing for the family.
- e. A period of no less than (10) ten years has elapsed since the marriage.

How is the number of annual approvals determined?

The Ministry of Energy and Infrastructure is committed to the annual financial allocations specified for the two categories of housing loans and grants, according to the financial budgets allocated by the government in this

regard, and the expected numbers are announced periodically.

How can the data of the submitted housing assistance application be updated?

The housing support applicant can update the housing assistance application data through the website or the Ministry's services application.

Is it possible to change the type of housing assistance after the approval decision is issued?

The type of assistance (loan, grant) is determined based on the monthly income of the beneficiary.

With regards to changing the value of the housing assistance, the grievance committee should given justification for reconsidering the approval decision. Changing the application from financial assistance to government housing or vice versa requires canceling the previous request and submitting a new application.

What are the necessary steps to be taken after issuing a housing assistance decision?

In case if the decision is related to financial assistance, it requires the applicant to apply for the requirements to open the implementation file during the validity period of the decision (one year) in one of the banks associated with the Ministry.

If the approval decision is for government housing, notifications and text messages will be received explaining the steps and stages of obtaining the house and the selected residential compound.



Questions related to the initial receiving service and housing ownership

What are the consequences/actions that will from the contractor and the delay fine is not be taken when the contractor delays the completion of work?

A delay fine worth 10% of the contractual value is charged on the contractor in case of non-compliance with the approved contract period.

What should I do if the contractor/consultant is not cooperating and does not abide by the contract?

It is possible to follow up the process related to individual housing (payments - engineering modifications) through the electronic systems and "Bayti" service on the website.

The house can be received with full facilities by the beneficiary or if the beneficiary according to the contract between the contracting parties, with the possibility of excluding some non-essential items if the It is possible to change the contractor and contracting parties agree on that.

The project cannot be extended unless it is The value of the contract cannot be changed after releasing the payments of the housing assistance.

> What are the process for changing a contractor and approving a new contractor? The process can be done by the issuance of a new building permit through the formal electronic systems.

Ouestions related to borrower services

Can the installments be postponed or the installment value be reduced if the rescheduling is accepted?

It is possible to apply to postpone or reduce the housing support installment after approval of requests to reschedule the payment of the arrears.

Can the delayed installments be paid over continuous or non-continuous periods?

The beneficiary can choose the repayment process and periods, provided that he does not exceed the loan repayment period.

Can late installments be postponed to the last payment phase?

It is agreed to postpone the late installments to the last payment stage if it is proven that the beneficiary did not cause a delay in the payment

How is the delayed installment reschedulina calculated?

The overdue amounts are paid in installments over a period not exceeding the loan repayment period, and then added to the current monthly installment until the payment of the arrears.

Does the beneficiary have to update the data and sign the direct debit form?

The beneficiary must go to the Emirates Development Bank headquarters to sign the direct debit form and update the data in order to avoid the accumulation of monthly installments.

What are the documents required to update the data?

More than one people may participate in the ownership of a boat, with a maximum of three people, provided that the necessary conditions and requirements are met.

Is a leisure boat allowed to be used by someone other than the boat owner?

It is not permissible to sail a boat without the presence of its owner, with the exception of relatives of the first or second degree, provided that the captain of the boat obtains a certificate of eligibility to sail, and a special permit from the Coast Guard.

Is there a fine for delaying the certificate of eligibility to sail a boat?

There are no fines if there is a delay in issuing a certificate of eligibility to sail a boat.

What is the age limit for obtaining a certificate of eligibility to sail a boat?

The minimum age to obtain a certificate of eligibility to sail a boat is 16 years

What is the age limit for registering a leisure boat?

The age of the applicant to register a leisure boat must be at least 18 years.

What is the validity period of the certificate of eligibility to sail a hoat?

The lifespan of the certificate of eligibility is currently one year, two years or five years.

Is it possible to extend the validity of the sailing card?

The validity of the sailing card cannot be extended.

Who is responsible for registering jet skies in the UAE?

there a difference between documents in the phase and the contracting phase?

Yes, the contract document is a legal document approved by both parties under the delegation of powers and a valid power of attorney by the second party, and it is a comprehensive document for all project documents during the offering

What is the process for signing and approving contractual documents?

- Signing the contract by the bidder personally or by his officially authorised agent according to the applicable regulations and the availability terms and of contractual documents (final bank guarantee, insurance policies, valid license, power of attorney acknowledgment).
- Approval of the contract by the first party (the Ministry / initiatives of the UAE's Rulers and representatives of the Ministry).
- Stamping documents with the seal of the Ministry / initiatives of the UAE's Rulers and representatives of the Ministry.

What are the conditions for the document to be considered legal?

Approval and signature of all parties to govern the relationship between the Ministry and the winning bidder.

final (bank) What is the quarantee?

It is a document issued by the approved banks in the country that guarantees the fulfillment

of the debtor's obligations. The purpose of the final bank guarantee letter is to protect the Ministry from financial loss in case if the contracting company fails to fulfill its obligations, and the bank issuing the final letter of guarantee will pay the agreed amount to the Ministry if the project is not completed. These documents are also called (bank guarantee), or (good performance guarantee). What are the terms of the final bank quarantee?

It shall be equal to 10% of the total contractual value for contracting works and 5% of the total value of study and design works for projects to provide engineering consultancy services, under an unconditional bank guarantee from one of the banks operating in the United Arab Emirates, which is accepted by the Ministry, provided that the validity of this guarantee begins from the date of signing the contract by both parties, and the contractor must renew the guarantee period until all the works subject to the contract are completed, and these works are accepted by the Ministry, and the computational settlement is made. Guarantees provided by financing companies are accepted.

How much time is given to bring the final bank guarantee? According to the notification sent to the winning bidder, he will be

given (5) working days from the date of notification, and if the period is exceeded, an alert message will be sent giving another (3) working days, after that a final warning message will be sent with a deadline of (2) working days. Prior to all the mentioned periods, the process of liquidating the initial bank guarantee will be initiated, with the price difference charged, plus 10% of the total value of the new contract as an administrative fees. All these amounts shall be collected from the dues of the winning bidder with the Ministry or any governmental or nongovernmental entity with no notification, warning or taking any legal action. Additionally, the Ministry has the right to remove the contractor's name from its suppliers' register.

Is it possible to have extra time to arrange the final bank quarantee?

Kindly contact the Engineering Contracts Department with an official letter, to study the possibility of being granted an additional deadline.

Is it possible to authorise another person to sign documents?

If the person authorised to sign is not present in the country, another person may be authorised to sign, provided that a power of attorney certified by a notary public or a state court is presented.

What is the value of the final bank guarantee required to be submitted for projects to provide engineering consultancy services? Is it 5% for study and design work only, or 5% of the total contract value?

A guarantee of 5% of the study and design work is required, and if the Ministry wishes to assign you supervision work, you will be notified to provide an additional bank guarantee of 5% of the contract supervision work, according to what is mentioned in the contract clauses.

the insurances required when signing a contract?

An original insurance policy that includes insurance for the value of the contract works for the period of the contract implementation until the initial handover of works. In addition to third party insurance worth 500,000 Dirhams for maintenance and additional projects, one million Dirhams for building construction projects, and two million Dirhams for road construction projects.

A valid copy of the workers' insurance policy.

Is it possible to amend the documents after opening the envelopes before the contract?

It is not permissible to amend the project documents by adding or subtracting unless the amendment is requested during the tender period.

How many copies are to be submitted?

One complete copy, including all documents, sealed and signed by the authorised signatory.

When can I apply for the advance?

After receiving a notification that the site is free of obstructions.

The Engineering Contracts Department undertakes the process of publicly opening envelopes in the presence of representatives of technical departments and all participants through the (Tender +) initiative, which allows participants to attend envelope-opening sessions remotely.

What is a primary bank guaran-

It is a document issued by the approved banks in the country that guarantee the fulfillment of the debtor's obligations. The purpose of the initial bank guarantee letter is to assure the Ministry that each candidate in the tender will accept the contract if he is chosen for the tender and will fulfill his obligations. In case if the candidate refuses to accept the contract, the bank issuing the initial letter of guarantee will pay the agreed compensation amount upon the request of the Ministry. Bearing in mind that cheques are not accepted, even if they are certified, and bank guarantees issued by finance companies are not accepted.



Engineering Contracts Section Questions

When is the initial bank guarantee released?

The initial bank guarantees are released immediately after the envelope-opening session for those who ranked fourth and above. The Ministry reserves the guarantees for the first, second and third bidders until the contracting procedures are completed and an appreciation letter is sent to all bidders mentioning the name of the winning bidder.

How can I obtain a letter for release of the bank guarantee from the Ministry?

You can obtain the required letter by submitting an application to the Department of Financial Resources.

How long is the tender analysis period?

The duration of bid analysis takes a maximum of 3 weeks, depending on the nature of each project.

How much is the fee for purchasing tender documents? How is it paid?

All companies have been exempted from the fees for purchasing tender documents according to Cabinet Resolution No. (38) of

Is it possible for my application to bid for a tender to be rejected even though I match the required category according to the tender announcement?

Yes, as the acceptance of companies for tenders depends on several criteria, including but not limited

The company should be classified under the project category.

The company shall not have any delay in the projects under implementation.

The evaluation of the company in previous and current projects should be good or above.

The value of the projects implemented by the company shall not exceed the maximum value of the category in which it is classified. The company shall not have projects under implementation on a wide geographical scale during the same period.

The company must fulfill the conditions set out in the tender announcement.

Is the decision to accept the bidding for the tender considered final? What are the cases and consequences of exclusion from bidding for the tender?

- Fulfillment of an initial bank guarantee of 5% of the total bid value.
- · The absence of any reservations that are not translated into values and financial impact.
- The company shall not have any delay in the projects under implementation.
- The prices offered should be reasonable (in the case of lumpsum contracts).
- · Providing the necessary commitments regarding low and high prices.
- The company should submit a project implementation action plan in terms of resource allocation.

- The company shall not have any delay in the projects under implementation for the Ministry.
- In case if the company has not previously worked with the Ministry, a statement of completion of projects on time as per the required quality is requested from any government authority previously worked with.
- The value of the projects implemented by the company in addition to the project under study shall not exceed the maximum value of the category in which it is classified.
- Fulfill all requirements set out in the tender documents.
